In the event of such illness or injury, I authorize Dance Force LLC to obtain necessary medical treatment for the Minor and hereby, in my own behalf and on behalf of the Minor, release and hold harmless Dance Force LLC, the Hosting site, on whose premises the Event will occur, the affiliates of Dance Force LLC., and the respective directors, officers, representatives, members, agents, coaches and employees of Dance Force LLC, the Hosting site and their respective affiliates (hereinafter collectively "Releasees") in the exercise of this authority. I further acknowledge and understand that I will be responsible for any and all medical and related bills that may be incurred on behalf of the Minor for any illness or injury that the Minor may sustain during the Event and while traveling to and from the site for the Event whether or not the Event actually occurs.

I, in my own behalf and on behalf of the Minor, further agree to release and to hold harmless Releasees from and all liability for negligence or any other claim, judgment, loss, liability, cost and expenses (including, without limitations, attorney's fees and costs) arising out of or connected with the Event, including any claim arising out of or connected with any illness or injury that the Minor may incur or sustain during the Event, all activities associated with the Event and while traveling to and from the site for the event whether or not the Event actually occurs. I further agree to indemnify and hold harmless Releasees and Releasee's heirs, successors, assigns, executors and administrators against loss from any further claims, demands or actions that may subsequently be brought by Minor or by any other person or persons on account of damages of any character resulting to Minor in any way from the foregoing activities. I further agree to reimburse and to make good to Releasees any loss, damage or costs Releasees may have to pay as a result of any such action, claim or demand.

Appearance Agreement. I understand that Dance Force LLC from time to time produces promotional material relating to its programs. I understand that as a participant in and/or a spectator at the Event the Minor may be included in videotapes or photographs taken during the Event. Therefore, without reservation or limitations, I, in my own behalf and on behalf of the Minor, hereby assign, transfer and grant to Dance Force LLC, its successors, assignees, licensees, sponsors, any television networks, and all other commercial exhibitors the exclusive right to photograph and/or videotape the Minor and to utilize such videotapes and photographs and Minor's name, face, likeness, voice and appearance as part of the Event, in advertising and promoting the Events or in advertising and promoting similar future events. I further understand that neither Dance Force nor any third party is under any obligation to exercise any of the foregoing rights, licenses and privileges.
